Spray Park Rules & Rental Information

The following policies, procedures and regulations are in addition to the general policies, procedures and regulations set forth in Resolution No. 137889. It should be noted that rules may vary in some cases depending upon the feature that is being utilized with the park.

- 1. The Spray Park is available for rental and must be reserved in person at the Park Office. The full payment is required at time of reservation credit card, money order or check only. The surrounding area is not inclusive in the rental and is not considered as rented space.
- 2. Renter will be held accountable for any damages sustained during their event.
- 3. Cancellations must be made in writing at least 10 working days by person making reservation. A \$25 cancellation fee will be assessed and 75% of the rental price will be refunded.
- 4. All persons using the Spray Park do so at their own risk.
- 5. In case of an emergency dial 911
- 6. NO SMOKING NO ALCOHOL
- 7. Spray Park is designed for recreational purpose only.
- 8. Neither Jefferson Parish nor Lafreniere Park is responsible for lost or stolen articles.
- 9. Seasonal hours of operations: Thursday Sunday 12pm 7pm, Weather Permitting (Memorial Day to Labor Day)
- 10. The park staff shall make decisions regarding weather.
- 11. Limited to kids ages 3 to 10.
- 12. Children 6 years of age or under must be accompanied by an adult at all times.
- 13. Aqua socks and sandals are recommended in the spray area.
- 14. Running, undue roughness, and horseplay are strictly prohibited.
- 15. Climbing or playing on components and hanging of clothes and towels on fence or trees is not allowed.
- 16. Bathing suits or proper clothing must be worn including swim diapers if needed.
- 17. Wheeled vehicles, others than strollers, walkers and wheel chairs are prohibited.
- 18. Animals others than service animals are prohibited. Service animals must have official markings
- 19. Food, Drinks and glass containers are prohibited.
- 20. Individuals engaging in unsafe or disruptive behavior will be asked to leave.
- 21. Patrons must bathe/shower prior to arriving to the spray park.
- 22. Capacity for the facility is 75 people.
- 23. Jefferson Parish employees cannot be given any type of gratuities, tips, compensation, etc.
- 24. This list is not all-inclusive of the rules & we reserve the right to add any rule that will benefit park visitors.

<u>Lafreniere Park – General Rules</u>

- 1. Park guest(s) will be held accountable for any damages sustained during their visit/rental.
- 2. All persons utilizing park facilities do so at their own risk.
- 3. In case of an emergency dial 911
- 4. Reservation information: Park office hours are Monday Friday, 8:30a.m. to 4:30p.m. except holidays. Park Office number is 838-4389, Fax 838-4387.
- 5. Signs are posted when shelters are reserved.
- 6. Firearms, fireworks, explosives, pyrotechnics, bow and arrows, BB guns, slingshots, or other potentially dangerous weapons are not permitted within Lafreniere park.
- 7. Motorized models such as miniature planes and rockets to include unmanned aircraft systems (Drones) are not permitted.
- 8. No soliciting of any type allowed including distribution of information and concessions on signage, flyers by hand or on vehicles, etc.
- 9. No swimming, personal water craft or gas-powered devices in the lagoon.
- 10. No overnight camping.
- 11. Frying / Boiling is not allowed expect by a registered caterer with a self-contained unit. All cooking fluids must be removed from park and cooking apparatus must be parked in designated parking lots only. Must have shelter rented to have caterer.
- 11. Park gates open at 6:00 a.m. and close for 9:45 p.m.
- 12. No motorized vehicles on ANY bridges, all grassy areas, pathways, sidewalks, overnight, etc. All will be subject to be towed.
- 13. Spacewalks only allowed at a rented shelter and must be delivered and picked up one hour before and after rental period by an approved vendor. Vendor list available at Lafreniere Park office. Generator is necessary vendor power source from park is not guaranteed.
- 14. Amusement rides and attractions are not allowed.
- 15. Bands / amplified music must have a special event permit.
- 16. Metal detectors are not allowed at any time.
- 17. All dogs must be properly leashed per J.P. Parish Ordinance Sec. 7 21.
- 18. All vehicles and accessories must park in designated parking lots.
- 19. BBQ pits are not guaranteed at shelters, no propane allowed. Do not dump hot coals in grass or trash cans.
- 20. Fishing Lafreniere Park has a catch and release policy. No fishing in the marsh island area.
- 21. Shelters do not move tables or benches. No tacks, nail, screws, etc. to be use on shelters.
- 22. Golf clubs use of is prohibited.
- 23. Glass containers are not allowed.
- 24. Vandalism of park property will not be tolerated. Violators will be reported to J.P.S.O. and prosecuted to the fullest extent of the law.
- 25. Tents (any type) are not allowed at any time.
- 26. Do not dig or stake anything into the ground.
- 27. Water play / soft play equipment is not allowed.
- 28. Wildlife do not interact with wild life within park. Releasing of any animal is strictly prohibited per J.P. Ordinance 7 126.
- 29. No décor / decorations on bridges.
- 30. Keep Lafreniere Park clean please place trash in proper receptacle.
- 31. No bikes on walking track.
- 32. This list is not all-inclusive of the rules & we reserve the right to add any rule that will benefit park visitors.
